The Senior General sprinkled scented water on the plaque of the centre and watched a video clip on the new building.

Speaking on the occasion, the Senior General said that the law is a prescribed provision by which all citizens and people residing in the nation must abide.

The Senior General stressed the need to accumulate legal knowledge for initiating the peace and stability of the nation, the rule of law and the socioeconomic development of the people, adding administrative authorities need to be skilful in legal affairs for their management measures and follow the laws.

As such, the Senior General added that all arts and science universities teach law subjects to confer BA (Law) degrees on graduates, and other significant universities give training to the students to get LLB degrees. Hence, he urged all legal experts in Myanmar to try hard to make further study from on-job training.

The Senior General instructed all to adopt better tactics for successfully implementing the legal knowledge dissemination process and ensure the long-term existence of the centre so that State service personnel and those in law careers can continue their studies at the centre.

Union Minister for Legal Affairs and Union Attorney-General Dr Thi Da Oo reported on undertaking legal affairs and conducting the legal knowledge courses.

The Senior General and party visited the centre.

# Late onset, early departure predicted for monsoon season

IT is forecasted that the monsoon will arrive late and leave early in the coming monsoon season, said U Hla Tun, a spokesperson from the Department of Meteorology and Hydrology.

Under current forecasts, the monsoon will be moderate plus late coming, and the beginning of the monsoon is possibly not good.

"If monsoon was late, the beginning of monsoon could not be fine. Under current forecasts, the monsoon will be late. The beginning of the monsoon is set from the time it enters to the end of June, so the later it arrives, the worse it is. According to the current forecast, the monsoon will be weak to just moderate. Rainfall depends on the strength of the monsoon. The strength of the monsoon is predicted to be weak to moderate, so the monsoon rain can't be much better. If the rain level is lower than the

the monsoon is not good. This monsoon is forecasted to be lower than average rain or stay at average rain, so the beginning of the monsoon won't be good," said U Hla Tun.

The monsoon will be just ordinary, even in mid-monsoon, he said.

"The mid-monsoon is from July to August. The strength of the monsoon is predicted to be moderate to strong, and nationwide rainfall is forecasted to be average, so this year's monsoon will be normal," he said.

Moreover, in the late monsoon period, the monsoon will leave early on 1 September, according to current forecasts.

"We've currently forecasted that the monsoon will leave on 1 September, so it means the monsoon will leave early. And rainfall is forecasted to be moderate in the late monsoon," he said. —

## Price hike dampens Pathein parasol use

THE price of Myanmar's traditional handmade Pathein umbrellas has increased, resulting in a decline in buyers who use them for interior decoration.

Some guessed that the price increase was a result of the transport barrier.

"Price gets quite high recently. During Thingyan, some buyers just asked, but they wouldn't buy due to the higher price. An umbrella was previously priced at just K8,000 per one. Now, we even have to buy at above K8,000, so

we have to re-sell it at around K9,000, which is cost-effective for us. The price started going up in the second week of April. Due to the rising price, people are not eager to use Pathein umbrella for decoration," said an official from Dudu Pathein umbrella trading in Mandalay. However, Myanmar's traditional handmade Pathein umbrellas gained popularity in the market in February, and the sales were pretty good. Local products — wood, bamboo umbrella axle, Tharagu bamboo, persimmon, satin fabric and cloth — are used mainly to make an umbrella originally produced in Pathein. The whole process is made by hand, including dying and painting over the entire body.

THE Department of Irrigation and Water Utilization Management (Water Resource) successfully supplied water to 15,492 acres of summer paddy via the river pumping processes in 2023-2024 in Yangon Region, and it is estimated to distribute water to 17,595 acres of summer paddy in 2024-2025.

"Our department distributes water from Hline, Kokkowa rivers and Ngamoeyeik creeks with a river pumping system to the summer paddy fields in Taikkyi, Hmawby, Hlegu and Htantabin townships in Yangon. We supplied water to over 12,000 acres the previous year and to 15,492 acres this year," said U Tin Maung Than, deputy director of the department.

"We started the river pumping system in early January, and we will suspend it in the first or second week of May. The suspension of water distribution date will be later than that date if there is a delay in spreading seed and if there might be well-matured paddy. The expansion of summer paddy fields is a new step for farmers to increase their socioeconomic growth. We successfully distributed summer paddy without any waste under the guidance of the State Head and close supervision of the regional government," he added.

He said, "We are now preparing to supply enough water to the expanded summer paddy in the coming year rather than this year. The ability to develop the plantation areas for local consumption and exports while the paddy rice is on the rise brings benefits to the farmers and country."

In 2023-2024, the Kyontu, Kamakalu and Khayan Chaung



monchon and Yemon pumping projects benefited 7,662 acres, and the target for 2024-2025 is 8,245 acres. Meanwhile, a total of 15,492 acres of summer paddy in these districts/townships were successfully distributed water with a river water pumping system in 2023-2024, and it is estimated to supply water to 17,595 acres in 2024-2025.

river pumping projects benefited 76 acres of summer paddy in Thanlyin district, and the estimation for 2024-2025 is 350 acres. In Mingaladon district, the Myitkyoe, Kankalay and Myaungtaga water pumping projects, distributed water to 1,320 acres of summer paddy, and it is estimated to be 1,890 acres in 2024-2025. Moreover, the Sangyi and

Balar (1) water pumping projects in Mingaladon township supplied water to 215 acres, and the earmark for 2024-2025 is 280 acres.

A total of 2,818 acres of summer paddy are planted with the use of water from Yaypawthaung, Gwytanshay, Kyogon and Kyunngu water pumping projects in Htantabin township, and it is estimated for 3,030 acres in 2024-2025.

The Aingkalaung, Alaboke, Thabyaykan, Tawlati, Taungyet Zeegone and Thayetchaung pumping projects benefited 3,401 acres in Taikkyi township, and the estimation for 2024-205 is 3,800 acres. In Hlegu district, the Balar (2), Malit, Yaykyaw, Sitbin, Sinphon, Ngwe Nantthar, Ngamoeyeik, Latpan, Latpan (2) Kinyearly to supply water to 24,518 acres from 22 completed electric water pumping projects, 3,300 acres from two electric water pumping projects (in progress) and 5,000 acres from six electric water pumping projects which are under the stage of Feasibility Study. — Nyein Thu (MNA)/ KTZH

## Solar system powers 24-hour electricity at Kaunghmudaw Pagoda

ACCORDING to the board of trustees, the installation of a solar system costs over K200 million to provide 24-hour electricity at Kaunghmudaw Pagoda in Sagaing Township.

The installation began on 6 April, completed on 12 April, and has been operational since 13 April 2024. Ninety-six solar panels capable of producing 56,160 watts have been installed in the southeast corner of the pagoda. Additionally, there are 32 sets of 450-watt searchlights, eight sets

of 240-watt searchlights, electric lights on the pagoda slopes, lighting for the pagoda square, purified water for pilgrims, water coolers, and three water dispensers for drinking water in the pagoda's buildings and shops, all available for 24-hour use.

The project received K100 million from the Sagaing Region government and K107 million from donors to ensure continuous power supply and energy conservation. Any surplus solar power will be utilized to operate

two water fountains in the pagoda round the clock. — TWA/TKO

ACCORDING to information from the Ministry of Transport and Communications, construction of the frontage road at Thilawa Port, including a traffic island, has been completed. The opening ceremony for the new road took place on 28 April.

The new road, measuring five miles and two furlongs in length, was constructed at a total cost of K28.35 billion, funded by the Myanma Port Authority and port business-

ing in safe and efficient transportation.

The newly constructed four-lane road is expected to enhance the role of Thilawa Port as a hub for combined transport (multimodal transport) and improve connectivity with inland circulation systems (hinterland connectivity). Additionally, traffic congestion is anticipated to decrease with the implementation of technology and innovation.

The construction of the new frontage road at Thilawa Port relied on collaborative effort involving the Ministry of Transport and Communications, supervision by the Yangon Region government, the Ministry of Construction, Yangon City Development Committee, Yangon Electricity Supply Corporation, contributions from Thilawa Port entrepreneurs, and oversight

# Rubber prices show uptick in late April

THE price of rubber bounced back on 29 April after a drop in early April, according to figures of the Mon State's rubber market.

The prices hit K1,780 per pound of Ribbed Smoked Sheet Local 3 and K1,760 for sun-dried rubber in early April. The prices stood at only K1,810 per pound for sundried rubber and K1,830 for RSS Local 3 on 29 April.

The figures indicated a slight increase of K50 per pound in the past four weeks.

Myanmar's rubber prices are influenced by global demand for rubber and rubber production in Southeast Asian nations, as well as the market supply.

The rubber price in Mon State, a significant rubber production state in Myanmar, is closely tied to those factors as

well, the traders elaborated.

Myanmar's annual rubber production is estimated at 300,000 tonnes. Seventy per cent of rubber produced in Myanmar goes to China. It is also shipped to Singapore, Indonesia, Malaysia, Viet Nam, the Republic of Korea, India, Japan, and other countries.

Myanmar shipped 114,855 tonnes of rubber with an estimated value of over US\$144 million as of 29 December in the last financial year 2023-2024, beginning 1 April.

The rubber production in the last FY 2022-2023 reached over 360,000 tonnes, and more than 200,000 tonnes of rubber were shipped to foreign trade partners.

Rubber is commonly produced in Mon and Kayin states and Taninthayi, Bago, and Yangon regions in Myanmar. As per 2018-2019 rubber season data, there are over 1.628 million acres of rubber plantations in Myanmar, with Mon State accounting for 497,153 acres, followed by Taninthayi Region with 348,344 acres and Kayin State with 270,760 acres.

Myanmar generated more than US\$449.102 million in revenue in rubber exports in the 2020-2021 FY. — NN/EM

# YGN palm oil wholesale reference rate dips this week ending 5 May

Ministry of Commerce informed the consumers of lodging the complaints for overcharging through the call centre's hotline in late August. The Department urged consumers not to buy palm oil at high prices. The Committee notified that any person who is involved in price gouging and oil storage to attempt market manipulation will face legal action under the Essential Goods and Services Law.

The complaints for overcharging can be lodged over the hotline 1535 of the call centre of the Consumers Affairs Department or sent to the Facebook page of the Department and the region and state departments concerned. The domestic consumption of palm oil is estimated at one million tonnes per year. The local palm oil production is just about 400,000 tonnes. About 700,000 tonnes of palm oil are yearly imported through Malaysia and Indonesia to meet domestic demands. - NN/EM

# 8,000 companies failing AR submission banned

ACCORDING to reports, more than 8,000 companies that failed to submit annual returns in the 2023-24 financial year have been removed from the register.

The Department of Investment and Company Administration said that companies were struck off from the registration list according to the Myanmar Companies Law.

Companies that failed to submit annual returns were expunged from the company registry under Section 97 of the Myanmar Companies Law, which is published regularly every month.

According to the published decrees, in the financial year

tember, 750 in October, and 600 in November, 450 in December, 750 in January, 600 in February and 1,650 in March 2024 failed to submit the report.

As a result, a total of 8,100 companies were withdrawn from the company registration.

In addition, more than 1,000 companies were also removed from the company registration in April 2024.

A total of 3,400 companies in the 2021-22 financial year and 5,100 companies in the 2022-23 financial year were also deregistered.

Therefore, according to the published list, 17,600 companies have been removed from the company registry as of April 2024. — TPT

THE wholesale reference rate of palm oil for the Yangon market declined to K5,220 per viss for the week from 29 April to 5 May 2024, according to the Supervisory Committee on edible oil import and distribution.

The figures decreased from K5,340 per viss last week ending 28 April.

The Supervisory Committee on Edible Oil Import and Distribution under the Ministry of Commerce has been closely observing the FOB prices in Malaysia and Indonesia, adding transport costs, tariffs and banking services to decide the wholesale market reference rate for edible oil on a weekly basis.

## Mark World Immunization Week 2024: Improving health standards

TORLD Immunization Week 2024, observed from 24 to 30 April, carries the theme "Humanly Possible: Saving lives through immunization." This year's focus is on reducing the fatality rate of preventable diseases through immunization, ultimately ensuring a brighter future for our children.

The World Health Organization emphasizes that this year's World Immunization Week celebrates 50 years of the Expanded Programme on Immunization (EPI). It acknowledges our collective efforts to save and improve countless lives from vaccine-preventable diseases. The WHO calls on countries to increase investments in immunization programs to protect future generations.

Between 2010 and 2018, measles vaccinations alone prevented 23 million deaths worldwide. Regular vaccination has prevented more than 20 life-threatening diseases and spared 24 million people from falling into poverty due to health expenses. Every dollar spent on measles vaccination yields a return on investment of \$76.5.

It is the time for all Mvanmar citizens to benefit from proper healthcare services. including necessary immunization projects implemented by the Public Health Department, Medical Services Department, Traditional Medicine Department, and other healthcare institutions managed by the government and private sectors. Consequently, everyone, including authorities, must create an environment conducive to nurturing healthy and fit children. free from infectious diseases and pandemic outbreaks.

During the immunization week held in Nay Pyi Taw and regions/states between 24 and 30 April, there was a double increase in vaccine coverage compared to 2021. Cooperation with relevant officials in primary healthcare services, including vaccination processes, was emphasized. Thanks to immunization projects, the World Health Organization recognized Myanmar as tetanus-free in 2010 and polio-free in 2014.

Recently, the Union Health Minister and party observed Special Immunization Activities for children, including Buddhist novices and nuns under 15, at Shwethaephyu Monastery in Dekkhinathiri Township. Immunization processes with a catch-up method for children under five were also conducted at Zeyathiri Township, urging all people to join hands in the immunization process together with authorities for the health conditions of their children.

Myanmar must improve its immunization coverage to prevent outbreaks of diseases such as COVID-19. Departmental officials need to enhance cooperation with local authorities to improve primary healthcare services. Moreover, the government procures vaccines annually to immunize people of all ages across the nation according to schedules. This ensures that people are protected from the impacts of pandemics triggered by communicable diseases. Therefore, local authorities must organize residents to ensure that children receive vaccinations and immunizations on time.

## Three Myanmar Language and Literature Scholars of Foreign Origin: An Appreciation By Dr Myint Zan

### **Anna Allott (Daw Khin Khin** Chaw)

Sayama Anna Allott (Daw Khin Khin Chaw) (1930-2024) passed away on 14 April 2024 in the United Kingdom at the age of 93. Notwithstanding her venerable age to those who value her contributions to Myanmar language and literature, her demise is indeed a great loss. She has studied, conducted research and written about Burmese language and literature for close to 70 years. Just before I learned of her passing through social media, by chance, I saw photocopies of articles written about Myanmar literati, including Thein Pe Myint and Pi Moe Hnin, by other Myanmar literati such as the late Maung Tha Noe and the late Ludu Sein Win (whose contributions Anna edited). The brief analysis and commentary of those writers were compiled by Sayama (Daw) Anna and published either as books or chapters about 20 years ago.

In a post that I read on social media, I noted that Anna did not like the 'mixing' of her name with Myanmar and English terms like 'Aunty Khin Khin Chaw' or 'Aunty Chaw'. She prefers to be called 'Ma Ma Chaw' or 'Daw (Daw) Khin Khin Chaw'. Henceforth, I will use either 'Anna' or 'Daw Khin Khin Chaw'.

A local child or, indeed, adult foreigners learning Burmese had to study the language first and then (perhaps) literature. Starting in the mid-1950s, Anna learnt the Burmese language. Later, she focussed more on literature, translating and commenting on various Myanmar novellas, short stories and poems.

As this is a personalised tribute, I should state that Anna initially (anonymously?) refereed to two articles that I sent to Westerly. A literary journal published by the English Department of The University of Western Australia.

The first article I sent to Westerly was my tribute to the late Sayagyi Minthuwun, and it was published with the title 'Minthuwun: A Tribute to a gentle Burmese Poet' in the 2005 issue of Westerly Journal. I know it was

sent to Anna since there is an addendum at the end of my article. Anna initially translated one of Minthuwun's poems, which was apparently written anonymously, and Ana mentioned a few of my comments in my tribute.

The second article of mine published in Westerly in 2010 was titled 'Shortened Cigars Stained with Nostalgic Tears'. The article is my translation and commentary of a poem by the now United States-based writer Maung Swan Yi after the death of his friend poet, Tin Moe. In his poem, Maung Swan Yi 'harked back' to the year 1959 when he, Tin Moe and another late poet, Kyi Aung, were 'mates in poetry', so to speak, while studying at the University of Mandalay. Maung Swan Yi recalled the occasion when Tin Moe impromptu composed the three-line short poem of one of his most well-known poems, Ei Thei Gyi ဧည့်သည်ကြီး ('The Great Guest'). I know my article was sent to Anna to referee it since the Editor of Westerly mentioned to me that Anna complimented my article and recommended its publication.

I have a brief discussion by email of the mixed style of Myanmar writing used by quite a few Myanmar writers where the formal (အရေးစကားပြေAyae Zagar Pyae) and colloquial (အပြော စ ကား ပြေ / စ ကား ပြော သ လို ရေး A Pwaw Zagar Pyae/Zagar Pwaw the Lo Yae) are mixed some time in the same paragraph indeed even in the same sentence. I would eschew the mixed use of colloquial and formal written styles. If one writes in a formal style like, say, the late U Aye Maung (Sarpay Beikman) or the late Paragu, then write them in that style in its entirety. If one prefers the colloquial or spoken style like, say, the late Ludu Daw Amar (in post-1966 of her writings) or the late Maung Tha Noe (in post-1965 of his writings), do write in that style, not 'mixed' ones. Anna wrote to me to the effect that writing styles do change, and she did not think that those who wrote in the mixed style(s) should be critiqued. Still, as far as Myanmar writing styles

are concerned, I am a 'purist'.

In the late 1990s, I enquired from her what the phrase Hnyi Khoan ညှိခုံ meant. She kindly replied to me in Myanmar language that it is like ညီအောင်ညှိNyi Aung Hnyi. From our correspondence, I gather that it means 'arbitral tribunal' in existence in the days of the Myanmar kings.

On 29 November 2003, on Kyee Kyee ('great aunt'), the late Ludu Daw Amar's 85<sup>th</sup> birthday, my article honouring the then-living literary lady doyen in Myanmar was published in the Jordan Times. Internet access was unavailable in the country at that time. Anna kindly brought a printout of my article to Mandalay during one of her visits and showed it to Daw Amar: Kyee Kyee mentioned to me with a smile that I have provided lots of information about her (ωξ: ရေးတာက စုံလို့ပဲMinn Yae Dar Ga Soan Loat Pae) in my article. I am grateful to Anna for bringing forth my article about Ludu Daw Amar to show to her.

Anna Allot had written at least three obituaries about three Burmese literary figures and published them in newspapers in Britain. The writer and translator Mya Thant Tint's obituary written by Anna Allott was published in the

Times of London, but as was the style and practice of the Times, Anna's name was not mentioned. Anna also wrote an obituary for another female doyen writer, Daw Khin Myo Chit, and I think it may have been published in The Independent or The Guardian in Britain. I do recall that she contacted me by email, perhaps to enquire or verify a few details about Daw Khin Myo Chit and also to ask for her photo when I said that she could try to write or phone the late family Anna replied somewhat tartly (as she occasionally did) that 'she did not want to bother the family'

On the night before I learned of Anna's passing, I was thinking of her comment that she tried to send her obituary tribute of Ludu Daw Amar to The Times of London (in April 2008), but at that time, Anna said many important figures in the UK and abroad were dying so there was no 'space' in the obituary pages of The Times. Hence, Anna's tribute to Ludu Daw Amar was published in The Guardian (UK) sometime in April 2008, sixteen years to the month, almost to the day before Anna herself passed away. The writer is unaware of whether or not tributes of Mrs Anna J. Allot



(alias) Daw Khin Khin Chaw appear in newspapers in the United Kingdom and elsewhere and, if so, who wrote them. This note is a personalised appreciation of her contributions to Myanmar language and literature.

### Saya John Okell (U Hla Thein)

Saya John Okell (1934-3 Au gust 2020) was a slightly younger contemporary of Anna Allott. Saya Okell's achievements in the Burma/Myanmar studies, especially in the field of linguistics, are of great significance. Among many others, he was the creator of Avalaser Burmese computer font. Yours truly is so technically unsophisticated that he does not know how to effectively use any of the Myanmar fonts, whether Avalaser, ခော်ဂျီZawgyi or ပြည်ထောင်စုPyidaung Su (Unicode). Saya Okell learned Burmese with the late Sayagyi Dr Hla Pe and his slightly older contemporary Anna Allott. The various books on Burmese linguistics, grammar, and colloquial usages that Saya Okell has produced since 1969 are significant contributions to this genre. Indeed, in 2002, Anna Allott and Saya John Okell jointly authored the Burmese/Myanmar Dictionary of Grammatical Forms.

It is stated that Anna Allott's main (not exclusive) focus or speciality was in the literature field. It can be argued that Saya John Okell's main (not exclusive) focus was in the field of linguistics and grammar. Still, Professor Okell also had an interest in Burmese literature and songs. As early as 1963, Sayagyi Dr Hla Pe (Professor of Burmese at the School of Oriental and African Studies), Anna Allott and John Okell published an article 'Three "Immortal". Burmese Songs' in the Bulletin of the School of Oriental and African Studies.

When Saya Okell's own Sayagyi, Dr Hla Pe, passed away, he wrote an obituary of Dr Hla Pe in the Bulletin of Burma Research Volume 5 No 1 & 2. I do not know whether or not Sayama Daw Khin Khin Chaw published an obituary of Saya John Okell, who passed away in August 2020 and who predeceased her by  $3\frac{1}{2}$  years. This humble (in one sense for Saya Okell, a much belated) and brief tribute to two leading Myanmar scholars from the United Kingdom can barely touch the contributions they have made.

### **Professor Ohno Turu**

Another Myanmar scholar of Japanese origin is Professor Turu Ohno (alternative spelling and designation Ono, Turu) (1935-7 October 2022). Ohno Turu taught Burmese/Myanmar at the Osaka University of Foreign Studies from 1965 to 2001. Saya Ohno Turu has published books about the Myanmar language, literature and aspects of Burmese history in Japanese, English and Myanmar languages. In 1969, Saya Ohno Turu published an article in Burmese ဒေသန္တရသုံးမြန်မာစကားများDethandaya-thoun bama-zaga mya ('The Burmese dialects') in the book ကဗျာအကြောင်း စာအကြောင်းKabyaakaung Sar Akyaung ('On Poetry and Prose'). This writer has also seen other articles written in the Myanmar language by Saya Ohno Turu.

I never had the chance to meet Saya John Okell. I am unsure whether I have personally met Saya Ohno Turu. Perhaps not.

I met a Japanese scholar at the Burma Studies Conference held in Gothenburg, Sweden, in September 2002. He is probably Professor Ryuji Okudaira (U Thitsar), who is now about 84 years old. U Thitsar's speciality is in pre-colonial Burmese history, and I have read a few of his articles written in English on that genre.

Incidentally, one of the highlights of the 2002 Gothenburg conference which I attended was that during the reception, a Russian scholar on Myanmar conversed initially in English with a Japanese scholar (probably Professor Okudaira), and then the Japanese scholar switched to Burmese, saying ကျွန်တော် မြန်မာလိုပဲ ပြောပါမယ် ວໂອpKyundaw Myanmar Lo Pae Pwaw Bar Mei Khin Bya ('I will now speak in Burmese'). Yours

truly joined the conversation and we all spoke the Myanmar Language. And this is the only time I have witnessed two foreign Myanmar scholars - a Russian and a Japanese-conversing in the Myanmar language!

(Daw) Yuri Takahashi, who teaches Burmese at The Australian National University, recently informed me that Saya U Thitsar is doing well. One wishes for his continued good health and to also make scholarly contributions.

The three scholars, Anna Allott, John Okell and Ohno Turu. passed away at an advanced age in their eighties and nineties. Verily, their contributions to the enhancement of the Myanmar language and literature are very significant.

## Confiscation of illegal items: Timbers, industrial materials, foodstuffs, consumer goods and vehicles

ON 26 April, combined enforcement teams confiscated a Hino Profia truck (valued at approximately K30 million) parked near Milepost 385/2 on the Mandalay highway. The truck was found to be carrying illegal teak logs weighing 13.195 tonnes, valued at K24.4 million. The action was conducted under the Forest Law.

On the same day, the on-duty teams intercepted an unregistered Nissan X-Trail truck (valued at approximately K20 million) and a Higer bus (estimated at K35 million) travelling from Hpa-an to Yangon. The vehicles were found to be transporting four sets of Felicity solar lithium iron phosphate batteries valued at K28 million at the Mayanchaung permanent checkpoint. Additionally, at the Myanmar Industrial Zone, goods from three containers, including 3,446.26 square metres of clear float glass from China, with a total value of K41.975 million, were seized as they were not declared in the Import Declaration (ID). The action was taken under Customs procedures.

On 27 April, combined teams confiscated four vehicles (with an estimated value of K95 million) heading to Yangon from Myawady. The cars were carrying seven kinds of goods valued at K29.66 million, including 885 kilogrammes of plastic tubes from Thailand without official documents, near the Hpa-an township detour. The seizure was conducted under Customs procedures.

Also, on 27 April, combined on-duty teams seized a Mitsubishi Fuso bus (approximately valued at K30 million) heading to Yangon from Myeik. The bus was found to be carrying three kinds of goods (estimated value of K5.26 million), including 360 bottles of Cook and Lobster fish sause from Thailand, without official documents. Additionally, illegal timber (charcoal) weighing 12.64 tonnes, valued at K189,600, was discovered at the Nyaungkhashay x-ray station. The action was taken under Customs procedures and the Forest Law.

The Illegal Trade Eradication Steering Committee reported 20 arrests made on 26 and 27 April, with an estimated value of K339.49 million. — MNA/ MKKS

Additionally, on 1 May, 6,050 tonnes of maize will be transported from The Myanmar Terminal – TMT 3, followed by 27,500 tonnes of maize from TMT 2 (Bo Aung Kyaw jetty) and 9,400 tonnes of maize from YIGT on 3 May. Moreover, on 5 May, a total of 27,500 tonnes of maize from Sule Port and 27,500 tonnes of maize from AIPT 1 will be transported. — MNA/TMT

## China-developed text-to-video large AI model unveiled in Beijing

Developed jointly by Tsinghua University and Chinese AI firm ShengShu Technology, Vidu stands out as China's pioneering video AI model, capable of effortlessly generating 16-second, high-definition videos in 1,080p resolution with a single click.

VIDU, a text-to-video large AI model capable of creating a 16-second, high-definition video in 1,080p resolution with a single click, was unveiled on Saturday at the 2024 Zhongguancun Forum in Beijing.

Developed by Tsinghua University and Chinese AI firm ShengShu Technology, Vidu is China's first video large AI model with "extended duration, exceptional consistency and dynamic capabilities."

As a large AI model developed in China, Vidu is able to understand and generate Chinese content such as the panda and the loong, or the Chinese dragon, according to Zhu Jun, deputy director of the Tsinghua Institute for Artificial Intelligence.

The company said that Vidu's core architecture was proposed as early as in 2022. — Xinhua

# New research shows Deep-sea black carbon comes from hydrothermal vents

THE ocean is one of the largest dynamic carbon sinks in the world, and is prone to increased carbon emissions from human activities. There are even proposals to use the ocean to sequester carbon in an effort to reduce the carbon emissions.

Associate Professor Youhei Yamashita and grad student Yutaro Mori at Hokkaido University, along with Professor Hiroshi Ogawa at AORI, The University of Tokyo, have revealed conclusive evidence that hydrothermal vents are a previously unknown source of dissolved black carbon in the deep ocean. Their discoveries were published in the journal Science Advances.

"One of the largest carbon pools on the Earth's surface is the dissolved organic carbon in the ocean," explains Ogawa. "We were interested in a portion of this pool, known as dissolved black carbon (DBC), which cannot be utilized by organisms. The source of DBC in the deep sea was unknown, although hydrothermal vents were suspected to be involved." – ANI

It further strengthened the region's human capital through increased support for education and health. and Iowa, a separate weather system Saturday brought 35 tornado reports from northern Texas and Oklahoma to Missouri, the National Weather Service (NWS) said.

The storms dumped up to seven inches (18 centimetres) of rain in some places within hours, and meteorologists warned of a continuing danger of extreme weather Sunday, including flash flooding, hail and more tornadoes.

Sulphur, in south-central Oklahoma, was particularly hard hit late Saturday, with videos and images posted on social media showing scores of buildings ripped apart.

A postal truck sat precariously atop wreckage of a building and trees, one video showed, with cinderblocks and wood beams strewn everywhere. ## Key insights from 1<sup>st</sup> day of WEF special meeting in Saudi capital

A special meeting of the World Economic Forum (WEF) themed around global collaboration, growth and energy for development ended its first leg of a two-day discussion on Sunday in the Saudi capital of Riyadh.

Leaders of the global economy and senior political leaders discussed hot topics, including inclusive growth, human capital, smart economy, and regional geopolitical stresses.

At the "Opening Plenary: A New Vision for Global Development," Managing Director of the International Monetary Fund (IMF) Kristalina Georgieva said following the spring meeting, the IMF concluded that the world has built stronger fundamentals for growth rate in recent years, showing

resilience to economic shocks.

However, she said, the world still faces two "very serious problems", referring to the 3.2 per cent forecasted growth for 2024, which is weak by historical standards, and "significant divergence across the world," with some countries doing well and others falling behind.

She stressed three economic priorities on inflation, fiscal buffers and geopolitical fragmentation and encouraged the diversification of supply chains, noting that good industrial policies do not come with the sacrifice of trade.

Following the opening plenary, Palestinian President Mahmoud Abbas reiterated his call for an immediate ceasefire in the Gaza Strip. —Xinhua

## EU says Apple iPad operating system to face stricter rules

THE EU on Monday said Apple's operating system for iPads must comply with tougher new rules that Brussels is imposing to rein in the world's biggest digital companies.

The European Commission designated Apple's iPadOS system as a "core" service under the landmark Digital Markets Act (DMA), which forces companies to modify their business ways to encourage competition between online platforms.

It joins other Apple products that were already in the DMA net since September: iOS for iPhones, the App Store, and EU-Apple tussle

### Indonesia's investment realization reaches over US\$24 bln in Q1

INVESTMENT realization in Indonesia reached 401.5 trillion rupiah (around US\$24.7 billion) in the first quarter this year, growing 9.8 per cent quarterly and 22.1 per cent annually, Investment Minister/Head of the Investment Coordinating Board Bahlil Lahadalia announced on Monday.

"From our target of 1,650 trillion rupiah (around \$101.45 billion) this year, now it has reached 24.3 per cent," Lahadalia stated at a press conference.

Collaboration between regional governments and the Board, which is proactive in approaching potential investors, has contributed significantly to this achievement, amidst global uncertainty and domestic political challenges, added Lahadalia. – Xinhua

### S Korea's mortgage-backed securities issuance falls in O1

SOUTH Korea's issuance of mortgage-backed securities (MBS) fell in double digits in the first quarter due to lower demand for government-backed mortgage loans, financial watchdog data showed Monday.

Apple has been one of the DMA's most vocal public critics. It claims the law ushers in privacy and security threats for users.

The commission, the EU's powerful competition regulator, said it named the iPadOS system because it locked users into the iPad operating system.

The operating system also "locked-in" Apple's business users, it said, "because of its large and commercially attractive user base, and its importance for certain use cases, such as gaming apps".

Apple has six months to comply with the DMA gatekeeper rules, the commission said in a statement. -AFP

The sale of the MBS, issued by the state-run Korea Housing Finance Corp to securitize mortgage loans, amounted to 5.9 trillion won (US\$4.3 billion) in the January-March quarter, down 16.3 per cent compared with the same quarter of last year, according to the Financial Supervisory Service. The double-digit decrease came from weaker demand for government-backed mortgage loans, affected by the faltering housing market and the high interest rates.

The central bank had left its benchmark interest rate unchanged at 3.50 per cent since January last year, after raising it by 3.0 percentage points for the past one and a half years. - Xinhua

## Chinese firms eager to showcase new products at Spain seafood fair

### China-Ecuador free trade agreement to take effect on 1 May

THE free trade agreement (FTA) between China and Ecuador will go into effect on 1 May as both countries have completed respective domestic approval processes, the Chinese Ministry of Commerce (MOC) announced Monday. The implementa-

tion of the FTA will unleash the potential of trade and investment between the two countries, promote comprehensive upgrading of bilateral economic and trade cooperation, and bring benefits to enterprises and people in both countries, the MOC said.

According to the deal signed in May 2023, approximately 90 per cent of the products traded between China and Ecuador will be exempted from tariffs, while about 60 per cent of them will enjoy zero tariffs immediately. — Xinhua

# US, Egypt 'hopeful' of Gaza truce as envoys meet in Cairo

US top diplomat Antony Blinken said Monday he was "hopeful" Hamas would accept the latest proposal for a long-sought Gaza truce and hostage release deal as negotiators from the Palestinian group were due in Egypt.

Egypt, Qatar and the United States have been trying to mediate an agreement between Israel and Hamas for months, and a recent flurry of diplomacy appeared to suggest a new push towards halting the fighting.

Talks "are taking place in Cairo today", said Al-Qahera News, which is linked to Egyptian intelligence services.

It was not clear whether the Hamas delegation had already arrived, but Qatari mediators were also in Cairo according to a source with knowledge of the talks.

A senior Hamas official said Sunday the Palestinian militant group had no "major issues" with the most recent truce plan.

Blinken — on his seventh visit to the region since the 7

October Hamas attack that sparked the war — told a World Economic Forum meeting in Saudi Arabia he was "hopeful" Hamas would accept a truce.

"Hamas has before it a proposal that is extraordinarily, extraordinarily generous on the part of Israel," Blinken said, urging the group to "de-

cide quickly".

"I'm hopeful that they will make the right decision."

Speaking at the same meeting, Egypt's Foreign Minister Sameh Shoukry said "the proposal has taken into account the positions of both sides."

While there was no "final

decision" yet, Shoukry said: "We are hopeful... I hope that all will rise to the occasion."

The war has brought the besieged Gaza Strip to the brink of famine, UN and humanitarian aid groups say, reduced much of the territory to rubble and raised fears of a wider regional conflict. — AFP

### Lao govt orders action to solve problems affecting people's livelihood

THE Lao government has instructed central and local authorities to work together to resolve the ongoing problems that are hindering the country's development and affecting people's livelihoods.

At the government's monthly meeting for April, the cabinet called for bold action to enforce solutions to address high inflation and regulate the price of goods while ensuring sufficient supplies of petrol, Lao national TV reported on Monday.

Strong measures must also be taken to bolster production in order to reduce imports and boost exports and foreign currency reserves while ensuring that investment capital enters the Lao banking system.

The cabinet emphasized the need to monitor large-scale hydropower and expressway construction projects as well as special economic zones to ensure they progress according to the set plans. — Xinhua

### Sri Lanka expresses hope to join BRICS+

SRI Lanka hopes to join BRICS+ in the near future, Sri Lanka's Ambassador to Russia Janitha Abeywickrema Liyanage said recently while addressing the media.

He made the remarks following Sri Lanka's participation in a recent international meeting of high representatives responsible for security issues in St Petersburg, Russia.

Liyanage said Sri Lanka could gain many benefits in transport and food security by joining BRICS+.

BRICS is the acronym for an emerging-market cooperative mechanism that initially includes Brazil, Russia, India, China and South Africa. On 1 January, Saudi Arabia, Egypt, the United Arab Emirates, Iran and Ethiopia joined BRICS, doubling its members from five to 10. – Xinhua

### At least 40 killed as dam bursts in Kenya amid heavy downpour

AT least 40 people have been confirmed dead, with several others still missing, after a dam burst in a town north of the Kenyan capital Nairobi, following heavy rains across the country, local police said Monday. Naivasha Police Commander Stephen Kirui said that they had recovered 40 bodies from the debris on Monday, with a major search and rescue operation ongoing in the Mai Mahiu area, about 60 kilometres north of Nairobi, after a nearby river overflowed due to flash floods. – Xinhua (Files) This photo taken on 24 July 2018 show cars burnt following a wildfire at the village of Mati, near Athens, on 24 July 2018. **PHOTO: AFP** 

NEARLY six years after wildfires killed more than 100 people at a Greek resort, an Athens court on Monday convicted six people of involuntary manslaughter and criminal negligence.

None of the politicians among the 21 people prosecuted were convicted, however, sparking fury among relatives of the victims present in court, media reports said. Six people — including the then head of the fire service — received suspended jail sentences of up to 111 years each for their role in the response to the inferno that tore through Mati on 23 July 2018. They were permitted by the court to reduce their sentences with a payment of up to 40,000 "The reaction is reasonable," minister of state Makis Voridis told Skai TV.

"This kind of a sentence is not commensurate with this kind of tragedy," he said.

Wildfires that broke out around Mati spread so fiercely that people burned to death in their cars because traffic jams prevented them fleeing.—AFP

In December 2021, the raw sting of Covid-19 — which shredded economies, crippled health systems and killed millions - motivated countries to seek a binding framework of commitments aimed at preventing another such disaster.

But big gaps remain between countries on how to go about it. Streamlined new draft

What was meant to be the ninth and final round of talks last month saw a 29-page draft swell to more than 100 as countries added proposed amendments. The Intergovernmental Negotiatversion on 22 April and wants to bar countries from proposing edits.

"The bureau is of the opinion that the text as presented in the proposal for a WHO Pandemic Agreement is consensus-ready. It was drafted on the basis of our many rounds of negotiations," it insisted.

The INB will present all 37 articles of the draft agreement, and if any countries object, they will be asked to explain their reasons.

If no quick fix can be found in the room, member states will dash off for informal talks to find a solution. - AFP
