

2025 MULTIPARTY DEMOCRACY GENERAL ELECTION

- Domestic election observers who wish to monitor the multiparty democratic general election, which will begin in phases on 28 December 2025, may apply for election observation permits at the Union Election Commission (UEC), as well as the relevant Region/State, District, and Township Election Subcommissions from today until 5 December 2025.
- The Union Election Commission announced on 16 September 2025 that domestic election observers must follow the Code of Conduct for Observers, issued under Notification 68/2025, and adhere to the procedures set out for their observation activities under Notification 69/2025. These notifications are available for viewing and can be downloaded from the Union Election Commission's official website https://www.uec.gov.mm.
- The Union Election Commission has also announced that international election observers will be allowed to monitor the multiparty democratic general election. Invitations will be extended directly to representatives of relevant countries and international organizations. In addition, through the Ministry of Foreign Affairs, invitations will be sent to representatives of foreign embassies, consulates, and permanent missions that maintain diplomatic relations with the Government of the Republic of the Union of Myanmar.



Writer urges Myanmar to learn from Bangkok sinkhole

CITING the landslide in front of Bangkok's Wachira Phayaban Hospital, author Mee Eain Shin Dr Nightingale suggested on social media that Myanmar should reduce the use of underground water to avoid such cases.

Heavy rains caused the landslide at 7:13 am on 24 September, resulting in a sinkhole about 150 feet (50 metres) deep. No one was injured, but the road has been closed, and 3,500 patients in the hospital have been moved to safer facilities.

According to landslide surveys, Yangon is one of the 48 cities in the world with subsidence.

"Yangon is one among 48 cities with subsidence. About two-thirds of the Yangon Re-

gion are facing it, and it is the worst in South Dagon Myothit, according to Singapore's Nanyang Technological University," she said.

Some areas of Yangon were sinking between 0.01 and 7.5 cm per year from 2014

to 2020, and the worst, South Dagon, suffered 7.5cm subsidence per year, possibly due to overusing underground water, said the study.

With an eight-million population, Yangon had to depend more on artesian wells for freshwater, while internationally funded water supply projects seemed to be stopped. Ground sinking was prominent in South Dagon Myothit and Hlinethaya, she said, quoting the study.

A 2014 paper titled "Yangon Seismic Analysis" published by researchers from Thailand's Chulalongkorn University and the Myanmar Earthquake Commission, based on satellite technology, suggests that the land between the Dagon University and the East Dagon Industrial Zone is sinking at a rate of more than two inches per year, possibly due to the extraction of excess groundwater, advising this factor to be considered in future Yangon urban development. - Htun Htun/ZN


MPBMSMA aims for US\$1.5B in pulses exports for 2025-26FY

MYANMAR'S pulses export is targeted to exceed 1.8 million tonnes in the current financial year 2025-2026, generating income of US\$1.5 billion, according to Myanmar Pulses, Beans, Maize and Sesame Seeds Merchants Association.

Myanmar delivered 2.14 million tonnes of various pulses to international markets in the previous financial year 2024-2025, bagging \$1.82 million.

At present, sluggish foreign demand has resulted in a downward trajectory.

Myanmar mainly exports black gram, green gram and pigeon peas to foreign markets. Of them, black gram and pigeon peas are primarily shipped to India, while green gram is exported to China and Europe.

India has a growing demand and consumption re-

quirements for black gram and pigeon peas. According

to a Memorandum of Understanding between Myanmar and India signed on 18 June 2021, India will import 250,000 tonnes of black grams and 100,000 tonnes of pigeon peas (tur) from Myanmar for five consecutive years from the 2021-2022 financial year to 2025-2026 FY. This G-to-G pact will not affect the pulses' annual quota set by India. Myanmar's exporters are also entitled to deliver the pulses to India under that yearly quota.

The Myanmar Pulses, Beans, Maize and Sesame Seeds Merchants Association stated that black grams, which India primarily purchases, are commonly found only in Myanmar, whereas pigeon peas, green gram and chickpeas are grown in African countries and Australia. — NN/KK

CBM secures US\$22M injection to fuel sector

THE Central Bank of Myanmar (CBM) announced on 23 September that it would pump US\$22 million to fuel oil sector.

Moreover, CBM sold \$800,000 to edible oil importing companies and over \$99,000 to fuel oil importing companies in addition to injection of over 8,500 yuan into the market on that day.

CBM injected over US\$1.7 million to edible oil and fuel oil importing companies on 22 September, selling over \$1.29 million to edible oil importing companies and over \$452,500 to fuel oil importing companies.

CBM pumped 758,400 yuan and over \$500,000 into financial market on 19 September. Those US dollar injection went to edible oil importing companies (over \$368,100), fuel oil importing companies (over \$79,000) and those who made non-trade payment (over \$58,000).

CBM sold over US\$1.15 million to edible oil importing companies and \$540,056 to fuel oil importing companies on 18 September.

CBM sold over \$1 million, 11 million yuan and four million baht in August. Furthermore, CBM also pumped over \$32 million, purchased from the companies working on a Cutting-Making

and Packaging basis, into the financial market. CBM aims to curb the instability in the foreign exchange market and currency devaluation. According to CBM's notification on 15 March 2024, it has been collaborating with law enforcement agencies to combat and prosecute those who attempt to manipulate the currency market under the existing laws. CBM allowed authorized dealers (private banks) to operate online foreign exchange trading freely as per the market rate, depending on supply and demand, starting from 5 December 2023. — NN/KK

European Union as a Supporter of the **Progressive Garment Industry of Myanmar**

1994, but the industry's growth accelerated only after international sanctions were lifted in the 2010s. The European Union (EU) suspended its sanctions against Myanmar in 2012 and opened an office in Myanmar in 2013. This paved the way for Myanmar to gain duty-free access to the EU market under the Generalized Scheme of Preferences (GSP) and the Everything But Arms (EBA) initiative in 2013.1 Myanmar's main exports to the EU are textiles, footwear, rice, and gems.²

EU as the Top Destination for **Myanmar's Garment Exports**

According to the World Bank, the value of Myanmar's garment exports surged from US\$0.9 billion in 2010 to US\$5.5 billion in 2022, a six-fold increase. A major turning point for the industry came in 2013 when the EU granted Myanmar under the GSP initiative. This preferential access proved highly beneficial, with EU countries receiving over half of Myanmar's total garment exports. By 2022, garment exports accounted for one-third of Myanmar's total export value. The sector's primary income, generated through CMP services, represented approximately one-third of the total garment export value, or about three per cent of Myanmar's GDP.3

Other key markets included Japan at 18%, the United Kingdom at 10 per cent, the United States at six per cent, and Korea at four per cent. This data highlights the EU's crucial role in supporting and sustaining Myanmar's gar-

areas of Myanmar, a core national policy has been to create employment opportunities alongside income generation for its people. In this regard, Myanmar's garment industry has proven to be the largest source of jobs, especially for young, migrant women from rural areas. Despite a decline in exports in 2020 and 2021 due to political changes and the COVID-19 pandemic, the sector rebounded strongly. By 2022, export levels had exceeded those of 2019, with an average of 95 per cent of garment factories resuming operations at their previous capacity to produce exports.

According to World Bank data, as of January 2022, Myanmar's garment sector employed around 500,000 workers as a major source of employment. This represented 2.3 per cent of the country's total employment and 23 per cent of all jobs within the manufacturing sector. By the end of 2022, the number of workers women in Myanmar's garment

In 2022, 34 per cent of garment factories in Myanmar raised their wages, leading to a five per cent average wage increase across the manufacturing sector compared to the previous year. This positive trend was reinforced by a national policy change, which increased the minimum wage from 4,800 to 5,800 Kyats in 2023. According to the World Bank, this enabled some factories, especially those that export to the EU, to boost their workers' wages by an additional 10 per cent to 20 per cent in 2023.

Although the share of Myanmar's garment sector in the global garment trade is small local garment entrepreneurs believe they can be competitive in the international market. They state that the main reasons for this are the abundant workforce and low wages.

Myanmar's Policy for Connecting with Migrant Workers Abroad

To ensure that workers going abroad for employment do so in a systematic and legal manner, the Overseas Employment Law was enacted, and efforts are underway to approve and enact an amended law to align with the current situation. The Five-Year National-level Action Plan for the management of labour migration to other countries has been drafted and implemented for the first and second times. To assist Myanmar workers abroad, labour attachés have been appointed in Korea, Thailand, Malaysia, and Japan. mar workers.5

According to the official EU website⁶ for Myanmar, over 90 per cent of Myanmar's exports were shipped to the EU, with preferential tariff rates under the EBA scheme in 2023. This shows that Myanmar is significantly benefiting from the EU's EBA scheme. In 2023, Myanmar's total exports to the EU under the EBA preferential system were valued at approximately €3.4 billion (US\$3.7 billion) while imports reached €3.0 billion (US\$3.2 bil-

In 2024, the EU stood as

Myanmar's 4th largest trading partner, accounting for 10.3 per cent of the total trade in goods. Conversely, Myanmar ranked as the EU's 75th largest trading partner, making up 0.1 per cent of the EU's total trade in goods. Similarly, total trade volume between the EU and Myanmar amounted to €3.6 billion (US\$3.9 billion) in 2024, while the EU's imports from Myanmar were primarily textiles, valued at €3.1 billion (US\$3.4 billion). Meanwhile, the EU's exports to Myanmar mainly consisted of transport equipment, accounting for €458 million (US\$495.60 million). Additionally, volume of trade services in 2023 reached €346 million (US\$374.41 million) between them.

Investment Situation

According to the official EU website for Myanmar, the volume of EU investment in Myanmar reached €251 million (US\$271.61 million) in 2023. As members of the EU Delegation serving abroad, staff must primarily adhere to the following principles:

(a) Adherence to the EU's Laws⁹. All actions of the delegation must strictly comply with the Treaty on European Union (TEU), the Treaty on the Functioning of the European Union (TFEU), and their subsequent laws, regulations, directives, and decisions. Furthermore, they must act in accordance with the EU's external action policies, including the Common Foreign and Security Policy (CFSP), trade policy, and development cooperation. For instance, when managing aid projects, the delegation must strictly follow the EU's procurement and financial regulations.

(b) International Law. Staff of the EU delegations must respect international diplomatic law, particularly the provisions of the Vienna Convention on Diplomatic Relations (1961)¹⁰. Specifically, under Article 41, while delegates have privileges and immunities, they are obligated to respect the laws of the host country. Failure to comply with these laws can lead to the host country declaring the diplomat or delegate "persona non grata" which is the most severe penalty for a diplomatic representative. This results in sending them back to the home country or terminating their functions. Additionally, under Article 31, their immunity does not exempt them from the jurisdiction of their home state. (c) Adherence to Financial Regulations¹¹. A core responsibility of the EU Delegation is to manage projects funded by the EU. This includes ensuring that contracts are awarded through fair and transparent processes (tendering and procurement) and that funds are used for their intended official purpose. The delegation that acts fraudulently or mismanagement is subject to financial audits and must take the necessary actions. All financial operations must be fully compliant with the EU's Financial Regulation to ensure accountability.

In short, the EU Delegation's legal and professional responsibilities are a blend of diplomatic duties. They must respect and adhere to the legal systems of the European Union, international law, and relevant laws of the host country. This mission involves a combination of upholding EU values like democracy, the rule of law, and human rights, providing development aid and fostering cooperation, engaging in public diplomacy and communication, and managing trade and econom-





Germany's Merz rejects claims he is slowing green shift

Opposition charges the conservative-led coalition is slowing green energy transition through gas power expansion and cuts to renewable subsidies.

GERMAN Chancellor Friedrich Merz on Wednesday rejected claims his government was undermining the climate change fight, but insisted that industry also needed to be protected to revive the crisis-wracked economy.

Critics charge that Merz's conservative-led coalition is putting a brake on the shift to green energy through measures ranging from a planned expansion of gas power to proposals to scrap some renewable energy subsidies.

In a fiery debate in parliament marked by loud heckling from the opposition benches, the chancellor noted his critics claimed he was "undermining climate protection".

"Nothing could be further from the truth," said Merz, whose

centre-right CDU/CSU bloc governs in coalition with the centre-left SPD.

He stressed he wanted climate protection "without ideology. That is the difference between us and the last government".

In the previous administration, the Greens party helmed the economy ministry and pushed ambitious measures to accelerate the energy transition — some of which caused unease among businesses about extra burdens at a time they were already struggling

"Climate protection that jeopardises or even destroys the industrial base of our country, climate protection that jeopardises our country's prosperity — that will not be accepted by the population," Merz said. — AFP

The mediator will try to develop a fraternizing strategy for dealing with the solitude of difficult people. Moreover, we can ask for advice from trusted colleagues about difficult people. Care should be taken not to handle everything alone in any relationship with difficult people.

Thirdly, we had better act but not react towards difficult people while building a relationship with them. Issac Newton's action-reaction theory is not wrong in all cases. Still, our reaction in the relationship with a difficult person is of utmost importance. Unless we react to difficult people in the right way during our relationship, the long-lasting relationship `bridge' will collapse to the ground in the not-too-distant future. Thus, no reaction is the best method of reacting towards difficult people in any circumstance, we should believe. For instance, difficult people tend to speak ill

of us in our presence. Nobody is perfect to the core, of course. Meanwhile, we had best make self-reflection on ourselves, whether we are flawless or not, no matter what difficult people are. Really, it often annoys us to encounter such people to a greater or lesser degree. Whether they do something upsetting on purpose or to no purpose, it is best if we always avoid reacting towards them. Our thoughtful actions can defuse situations by focusing on finding solutions, not the issue itself.

Fourthly, we have to show empathy to difficult people. One of the root causes of some people becoming difficult is nothing but their socioeconomic conditions. In today's age, everyone is still beset with his or her difficulties related to education, jobs, income, work domain, marital status, friendship and so on. Here, considering what we would do if we were them is certainly needed. Without empathy, sympathy is blind_talking about sympathy

with no empathy just looks like shedding crocodile tears for the difficult. For instance, the main reason why a difficult person hesitates to donate some money to others may be that he himself is mean, or he is so poor that he cannot afford it, or he has another valid reasoning or rationalization for being unable to do so. We must also try to understand difficult people's perspective, listen actively to their concerns and finally respond with kindness and patience.

Everything has a limit, I think. Beyond the limit, anything will be fragile for sure. Hence, people also have an extent to which they can put up whilst having a relation with others. Then, fifthly, we will have to set boundaries between our relationship with difficult people. What boundaries must be marked in a difficult relationship? We need to clearly communicate what is acceptable, be consistent with our boundaries and enforce consequences if necessary. For

instance, a difficult person may gossip about our personal lives or criticize us for personal injury. In fact, idle gossiping or destructive criticism is under no condition acceptable. Therefore, we should, in advance, say to difficult people that such gossiping or criticism is unacceptable at all times, as this can lead to an easily broken relationship at times. Within the boundary, any healthy relationship can be created, even very quickly.

Sixthly, we must be able to understand the behaviour of difficult people. We will be required to concentrate on the actions of a difficult person, not the person. We may or may not dislike his behaviour, but not the individual at all. That is why if we do not tell the difference between people and manners, hatred and neglect will only be a vicious cycle between us. For instance, difficult people are given to telling a barefaced lie to us sometimes. Even though it is a kind of white lie, there might be no lies that are good for all time. On occasions, we wrongly believe someone's lies with our eyes shut so that we can avoid making a U-turn in our lives. Accordingly, we should identify which actions bother us quite frankly every time we start to meet difficult people. By doing so, difficult people may abstain from their manners that can disturb others.

At last, it is better if we stay positive together with difficult people. We can keep a positive mindset, which means that people are just people, and as long as the human species exists in the world, the personality trait of difficult relationships with others will be in the bag to be seen, humorous to say. Accordingly, we must pay attention to merely what we can control as regards difficult people. And we have to maintain a calm and professional demeanour. The way we talk is the life of our relationship with difficult people. After all, we ought to give difficult people a helping hand as much as we can afford to have a wide circle of friends in the human atmosphere, just because difficult people are people only.

Indian stock market retains positive long-term outlook over stable macro economics: Report

India's GDP showed strong growth, exceeding expectations due to robust manufacturing and government spending, with GST reforms expected to boost consumption and ease inflation.

INDIAN equity markets retain a positive long-term outlook, backed by a normal monsoon, sustained policy reforms, government capex, and the financialization of savings — which continue to underpin India's growth trajectory, according to PL Wealth, the wealth management arm of PL Capital (Prabhudas Lilladher).

In its Market Outlook – September 2025, the report notes that India's GDP for

The outlook has been further buoyed by the GST rationalization effective September 2025, which is expected to lift growth by 0.2-0.3 per cent, spur consumption, and ease inflationary pressures. — ANI

UK rail operators set for new EU border checks

THE Channel Tunnel's operator and train service Eurostar have expressed confidence that the European Union's much delayed new border-check system will run smoothly when launched next month.

A phased launch from 12 October of the Entry/ Exit System (EES) for non-EU nationals replaces passport stamps with fingerprints and face photos thanks to a series of scanners installed at airports, ports and railway stations across Europe.

With Britain no longer part of the EU following Brexit, Eurostar and Tunnel operator Getlink have installed new systems in the country at a cost of tens of millions of euros (dollars).

"Everything is ready, everything is prepared and everything has been tested already with hundreds of customers," Getlink chief executive Yann Leriche told AFP on Tuesday near the entrance to the Tunnel in Folkestone, southeast England, that connects to France. "We are absolutely confident that it will be a success in October", Leriche added, amid concerns the new system could cause travel delays.

The CEO noted that six out of 10 cars departing the UK were using the Tunnel to cross the Channel, with the remaining 40 per cent using ferries from nearby Dover port. — AFP

Nissan halts US production of Ariya EV amid Trump tariffs, weak demand

NISSAN Motor Co has temporarily suspended production of its Ariya electric vehicle for the US market, company sources said Tuesday, amid sluggish demand and high tariffs under US President Donald Trump's administration.

Ariya, manufactured at Nissan's Tochigi plant in eastern Japan, has been exported to the United States, but sales are set to end once local inventories are depleted, the sources said. The suspension covers the 2026 model year currently being produced, while production plans for subsequent models remain undecided. Nissan will continue making Ariya units for the domestic market, according to the sources. — Kyodo


Australian telco giant slapped with \$66 million fine over 'appalling' conduct

EMBATTLED Australian telco giant Optus was hit with a \$66 million fine on Wednesday over "appalling" sales conduct as the firm grapples with fallout from a network outage linked to several deaths.

A federal court ruled the company — one of Australia's top telecoms providers — should be punished for selling products to vulnerable customers between 2019 and 2023 that they did not need or want, leaving many in debt.

Many of these people were also Indigenous and lived in remote parts of the country.

Federal Court's Justice Patrick O'Sullivan labelled the company's

Perrier sales ban

AN influential consumer rights association on Wednesday urged a court to ban the sale of Perrier bottled water in France, saying the brand's claim that its product is "natural" was misleading.

UFC-Que Choisir, which lodged its request with a court in Nanterre

near Paris, said the Nestle-owned Perrier brand should be banned temporarily from selling its sparkling water and be ordered to stop its "dishonest" description of the water. "Consumers buy water that is sold as natural mineral water but it isn't natural because it has been treat-

ed," the association's lawyer Alexis Macchetto told AFP. In early 2024, media reported that Nestle Waters—which also owns the Vittel and Contrex brands—had deployed banned processes to improve its quality, including ultraviolet treatment and activated carbon filters.—AFP

Thai authorities rush to battle Bangkok sinkhole

Heavy rain eroded a possibly leaking underground water pipe, per Bangkok disaster agency head Suriyachai Rawiwan.

AUTHORITIES in the Thai capital of Bangkok on Wednesday were tackling a large sinkhole that appeared when a piece of busy road collapsed 50 metres (160 feet) into the ground.

The sinkhole appeared in front of the city's main hospitals and near

a police station in a residential neighbourhood of the city. The site was cordoned off and people living and working nearby were asked to evacuate. Suriyachai Rawiwan, head of Bangkok's disaster agency, told the AFP news agency that heavy rain likely eroded a large underground water pipe that may have already been leaking, causing the damage.

Thailand's Prime Minister Anutin Charnvirakul told reporters that "dirt from an underground train construction was sliding in", exacerbating the issue. — ANI

India's education sector remains prime cyberattack target: Report

INDIA'S education and research sector continues to remain one of the most targeted industries for cyberattacks, according to the latest Threat Intelligence Report from Nasdaq-listed Check Point Software Technologies Ltd.

The report noted that the sector faced an average of 7,095 weekly attacks per organization, placing it above government institutions and consumer goods companies, and second globally only to healthcare.

Following education, the most targeted sectors were government with 5,140 weekly attacks and consumer goods and services with 3,889 weekly attacks. — ANI

Anti-nuclear exhibition opens in nuclear weapons state Pakistan

AN exhibition protesting against nuclear weapons has opened in nuclear-armed Pakistan, with its creator saying his brass sculptures were made based on how he imagined the sufferings of the victims of the 1945 atomic bombings in Japan.

The "Remains of Ruins" exhibition by Bashir Ahmad, a pioneering Pakistani miniature painter and sculptor, comes as this year marks 80 years since the atomic bombs were dropped on Hiroshima and Nagasaki in the closing days of World War II. It is being held from Tuesday.

Ahmad, now in his 70s, hopes to send a message to the public that nuclear weapons should not be produced. He said he chose to make his sculptures out of bronze since weapons are made of metal. It took him seven years through 2008 to come up with the roughly 30-centimetre-tall figures representing the human cost of the attacks. — Kyodo

Vietnam breaks ground on projects for APEC in 2027

A groundbreaking ceremony on several infrastructure projects was held on Wednesday in southern Vietnam's An Giang province, to serve the APEC Economic Leaders' Meeting in 2027, local daily newspaper Nhan Dan (People) reported.

The projects include roads, water supply infrastructure, smart city facilities, waste treatment, and a conference center. They are parts of a broader package of 21 infrastructure projects for the meeting.

Deputy Prime Minister Nguyen Chi Dung urged relevant ministries and local authorities to complete all works three to six months ahead of schedule, ensuring safety, transparency, and compliance with international standards to be ready for the meeting. — Xinhua

Italy deploys frigate after drone 'attack' on Gaza aid flotilla

ITALY dispatched a navy frigate to waters off Crete on Wednesday after a Gaza-bound aid flotilla reported drone attacks near Greece, prompting Rome to condemn the incident and urge Israel to safeguard Italian citizens aboard.

Italy's Defence Minister Guido Crosetto sent a navy frigate Wednesday to assist a Gaza-bound aid flotilla, after organizers said several of their boats had been targeted by drones off Greece.

The Global Sumud Flotilla said more than a dozen explosions were heard around the flotilla late Tuesday, with damage caused by "unidentified objects" dropped on deck. — AFP

Serbia hosts international defence fair

THE 12th International Arms and Defence Equipment Fair "Partner 2025" opened in Belgrade, Serbia, on Tuesday.

The event attracted a record 200 exhibitors from more than 30 countries, including leading European and global defence companies, according to the Ministry of Defence. Major European participants include France's Safran and Thales, the Czech Republic's Aero Vodochody and Ceska Zbrojovka, as well as Switzerland's B&T AG. — Xinhua

The Japanese company signed the agreement in 2014 with the group, which owns and operates football clubs in Europe, Asia and the United States, and publicized its brand through football matches.

of Yokohama F Marinos, a football club based near Tokyo, with Nissan being a major share-holder of the company. The termination comes as the automaker aims to restore profitability through restructuring measures, including reducing its global workforce and production capacity.

Nissan posted a net loss of 670.90 billion yen (\$4.5 billion) for fiscal 2024, hit by lackluster sales in the United States and China. — Kyodo

In his address to the UNGA, UN Secretary-General Antonio Guterres said the world has "entered an age of reckless disruption and relentless human suffering", with the principles of the United Nations "under siege" and the pillars of peace and progress "buckling under the weight of impunity, inequality, and indifference."

Noting that the world is becoming increasingly multipolar, Guterres said multipolarity without effective multilateral institutions courts chaos.

"The choices we face are not part of an ideological debate. They are a matter of life and death for millions," he said, adding that peace rooted in international law is humanity's first obligation.

The general debate will conclude on 29 September. Representatives and heads of state and government will also attend a series of high-level conferences and hold bilateral meetings during the High-level Week from 22 to 30 September. — Xinhua
